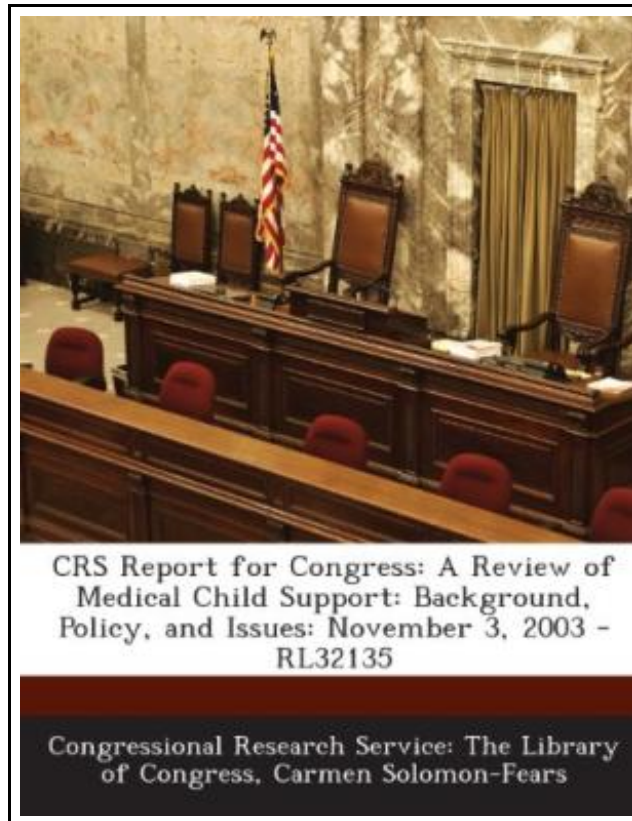

It can include provisions to cover health insurance costs as well as cash payments for unreimbursed medical expenses. According to 2001 Child Support Enforcement (CSE) data, 93 of medical child support is provided in the form of health insurance coverage. The requirement for medical child support is apart of all child support orders (administered by CSE agencies), and it only pertains to the parent s dependent children. Activities undertaken by CSE agencies to establish and enforce medical child support are eligible for federal reimbursement at the CSE matching rate of 66 . The medical child support process requires that a state CSE agency notify the employer of a noncustodial parent who owes child support, that the parent is obligated to provide health care coverage for his or her dependent children. CSE agencies notify employers of a medical child support order via a standardized federal form called the National Medical Support Notice. The plan administrator must then determine whether family health care coverage is available for which the dependent children may be eligible. If eligible, the plan administrator is required to enroll .
